# The scope of intangible cultural properties 日本における無形の文化財の範囲

- Art and skill employed in drama, music and applied arts, and other intangible cultural products which possess a high historical and/or artistic value in and for this country (hereinafter referred to as "intangible cultural properties") (Law for the Protection of Cultural Properties, Article 2, Paragraph1, Item(2))
- 演劇、音楽、工芸技術、その他の無形の文化的所産で我が国にとって歴史上又は芸術上価値の高いもの(以下「無形文化財」という)

#### (文化財保護法第2条第1項2号)

- Manners and customs related to food, clothing and housing, livelihoods, religious faiths, annual observances, etc., as well as to folk performing arts, folk techniques, clothes, implements, houses and other objects used therefore, which are indispensable for the understanding of changes in our people's modes of life (hereinafter referred to as "folk-cultural properties") (Manners and customs, folk performing arts and folk techniques related to related to food, clothing and housing, livelihoods, religious faiths, annual observances intangible folk cultural properties)
   (Law for the Protection of Cultural Properties, Article 2, Paragraph1, Item(3))
- 衣食住、生業、信仰、年中行事等に関する風俗慣習、民俗芸能、民俗技術及びこれらに用いられる衣服、器具、 家屋その他の物件で我が国民の生活の推移の理解のため欠くことのできないもの(以下「民俗文化財」という)(衣 食住、生業、信仰、年中行事等に関する風俗慣習、民俗芸能、民俗技術…無形の民俗文化財)

#### (文化財保護法第2条第1項3号)

• The Minister of Education, Culture, Sports, Science and Technology may designate as traditional conservation techniques those traditional techniques or craftsmanship which are indispensable for the conservation of cultural properties and must be preserved with special measures.

(Law for the Protection of Cultural Properties, Article 147)

   (文化財保護法第147条)
  - Drama and music, applied art, manner and customs, folk performing art, folk techniques, selected preservation techniques
